Its responsibilities include formulating the country's energy strategy, implementing energy policies, and regulating various energy sectors such as coal, electricity, oil, gas, and nuclear power. What does the NEA do? It also supports science and technology research on energy efficiency and renewable energy. Additionally, the NEA formulates plans for China's national reserves of oil and gas, although in China's March government reorganization, the National Food and Strategic Reserves Administration took over the management of these reserves.

What are the responsibilities of the National Energy Agency (NEA)? Its responsibilities include formulating the country's energy strategy, implementing energy policies, and regulating various energy sectors such as coal, electricity, oil, gas, and nuclear power. The NEA also supports research on energy efficiency and renewable energy technologies. Who publishes energy policy documents? Exhaustive overview of policy documents as published by the National Energy Administration and the National Development and Reform Commission. Policies from other agencies (see also below) will be added when highly relevant to energy developments. What does the Energy Management Department do? Responsible for daily operations including filing, financial management, asset management, petitions, energy industry statistics, and forecasting and early warning. It also coordinates with the Office of the National Energy Commission. Which states spend the most on energy? According to our recently published State Energy Data System information for , Alaska has the highest per capita energy expenditures of any state at \$12,100. Wyoming and North Dakota spent the next most at \$10,100 and \$9,300 per capita, respectively, which is twice as much as the national average of \$4,700.
